Slovakia gained distinction among the open education community by being among the first two countries

(along with the United States) to explicitly recognize the significance of open education in and OGP plan, and the first to incorporate both open educational resources and open access to scholarly publications. In fact, Slovakia was in the process of developing its commitments simultaneously with the U.S. during the fall

of 2014, and information about Slovakia's plans was discussed during the U.S. consultation process

The initiative has also had an impact in the central European region, where it attracted the interest of the
